- 1. The name of this corporation is KPFA Foundation.
- 2. (a) This corporation is a nonprofit Public Benefit Corporation and is not organized for the private gain of any person. It is organized under the Nonprofit Public Benefit Law for public and charitable purposes.
 - (b) The specific purposes of this corporation are

 - (2) To support, operate and/or establish for educational purposes one or more radio broadcasting stations and other media transmission facilities.
